COMMITMENT FOR TITLE INSURANCE


This Commitment shall be effective only when the identity of the Proposed Insured and the amount of the policy or policies committed for have been inserted in Schedule A by the Company.


The Company will provide a sample of the policy form upon request.

CONDITIONS

1. The term mortgage, when used herein, shall include deed of trust, trust deed, or other security instrument.
2. If the proposed Insured has or acquires actual knowledge of any defect, lien, encumbrance, adverse claim or other matter affecting the estate or interest or mortgage thereon covered by this Commitment other than those shown in Schedule B hereof, and shall fail to disclose such knowledge to the Company in writing, the Company shall be relieved from liability for any loss or damage resulting from any act of reliance hereon to the extent the Company is prejudiced by failure to so disclose such knowledge. If the proposed Insured shall disclose such knowledge to the Company, or if the Company otherwise acquires actual knowledge of any such defect, lien, encumbrance, adverse claim or other matter, the Company at its option may amend Schedule B of this Commitment accordingly, but such amendment shall not relieve the Company from liability previously incurred pursuant to paragraph 3 of these Conditions and Stipulations.
3. Liability of the Company under this Commitment shall be only to the named proposed Insured and such parties included under the definition of Insured in the form of policy or policies committed for and only for actual loss incurred in reliance hereon in undertaking in good faith (a) to comply with the requirements hereof, or (b) to eliminate exceptions shown in Schedule B, or (c) to acquire or create the estate or interest or mortgage thereon covered by this Commitment. In no event shall such liability exceed the amount stated in Schedule A for the policy or policies committed for and such liability is subject to the insuring provisions and Conditions and Stipulations and the Exclusions from Coverage of the form of policy or policies committed for in favor of the proposed Insured which are hereby incorporated by reference and are made a part of this Commitment except as expressly modified herein.
4. This Commitment is a contract to issue one or more title insurance policies and is not an abstract of title or a report of the condition of title. Any action or actions or rights of action that the proposed Insured may have or may bring against the Company arising out of the status of the title to the estate or interest or the status of the mortgage thereon covered by this Commitment must be based on and are subject to the provisions of this Commitment.
5. *The policy to be issued contains an arbitration clause. All arbitrable matters when the Amount of Insurance is \$2,000,000 or less shall be arbitrated at the option of either the Company or the Insured as the exclusive remedy of the parties.  - (c) Encroachments, overlaps, boundary line disputes, or other matters which would be disclosed by an accurate survey or inspection of the premises.
 - (d) Any lien, or right to a lien, for services, labor, or material hereto or hereafter furnished, imposed by law and not shown by the public records.
 - (e) Rights of dower, homestead or other marital rights of the spouse, if any, of any individual insured.
 - (f) Restrictions upon the use of the premises not appearing in the chain of title to the land.
3. Special Exceptions:
 - (a) Subject to Restrictions filed of record in Instrument No. 200604070084182, as amended in Instrument No. 200610100031372, both in the Register's Office for Knox County, Tennessee.
 - (b) Subject to matters shown on the recorded map of record in Instrument No. 200511220045763, in the Register's Office for Knox County, Tennessee, which indicates the following: a) a 20 foot minimum building set back line on front; 35 feet on rear; 5 feet on sides; b) a 5 foot utility and drainage and construction easement inside all lot lines; 10 feet inside road and exterior lot lines; c) a 15 foot sanitary sewer easement; 7.5 feet on each side as installed, where applicable; d) vehicular access for all lots is limited to interior road system only; e) 400 feet of sight distance as defined by the Knoxville/Knox County Minimum subdivision regulations is certified in both directions at the intersection of Gray Eagle Lane and Bob Gray Road.
 - (c) All assessments and taxes for the year 2010 and all subsequent years.
 - (d) This property may be subject to fees, dues and assessments of a Homeowners' Association.
 - (e) Subject to zoning ordinances which control the uses which may be made of the property.
 - (f) This conveyance is made subject to applicable restrictions, building set-back lines, existing easements and to all conditions as shown on the recorded map(s).
