COMMITMENT FOR TITLE INSURANCE

This Commitment shall be effective only when the identity of the Proposed Insured and the amount of the policy or policies committed for have been inserted in Schedule A by the Company.

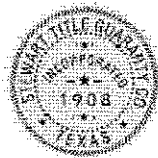




This Commitment shall not be valid or binding until countersigned by a validating officer or authorized signatory.

CONDITIONS

1. The term mortgage, when used herein, shall include deed of trust, trust deed, or other security instrument.
2. If the proposed Insured has or acquires actual knowledge of any defect, lien, encumbrance, adverse claim or other matter affecting the estate or interest or mortgage thereon covered by this Commitment other than those shown in Schedule B hereof, and shall fail to disclose such knowledge to the Company in writing, the Company shall be relieved from liability for any loss or damage resulting from any act of reliance hereon to the extent the Company is prejudiced by failure to so disclose such knowledge. If the proposed Insured shall disclose such knowledge to the Company, or if the Company otherwise acquires actual knowledge of any such defect, lien, encumbrance, adverse claim or other matter, the Company at its option may amend Schedule B of this Commitment accordingly, but such amendment shall not relieve the Company from liability previously incurred pursuant to paragraph 3 of these Conditions and Stipulations.
3. Liability of the Company under this Commitment shall be only to the named proposed Insured and such parties included under the definition of Insured in the form of policy or policies committed for and only for actual loss incurred in reliance hereon in undertaking in good faith (a) to comply with the requirements hereof, or (b) to eliminate exceptions shown in Schedule B, or (c) to acquire or create the estate or interest or mortgage thereon covered by this Commitment. In no event shall such liability exceed the amount stated in Schedule A for the policy or policies committed for and such liability is subject to the insuring provisions and Conditions and Stipulations and the Exclusions from Coverage of the form of policy or policies committed for in favor of the proposed Insured which are hereby incorporated by reference and are made a part of this Commitment except as expressly modified herein.
4. This Commitment is a contract to issue one or more title insurance policies and is not an abstract of title or a report of the condition of title. Any action or actions or rights of action that the proposed Insured may have or may bring against the Company arising out of the status of the title to the estate or interest or the status of the mortgage thereon covered by this Commitment must be based on and are subject to the provisions of this Commitment.
5. *The policy to be issued contains an arbitration clause. All arbitrable matters when the Amount of Insurance is \$2,000,000 or less shall be arbitrated at the option of either the Company or the Insured as the exclusive remedy of the parties. I. Requirements:

Instruments in insurable form which must be executed, delivered, and duly filed for record:

- (a) Owner's Lien Affidavit must be properly executed and furnished Fairway Title Company.
- (b) Notice and Waiver (declining Owner's Title Insurance) must be properly executed, and furnished Fairway Title Company if the purchaser(s) do not desire an Owner's Title Insurance Policy.
- (c) You must tell us in writing the name of anyone not referred to in this commitment who will get an interest in the land or who will make a loan on the land. We may make additional requirements or exceptions relating to the interest of the loan.
- (d) Warranty Deed from Delmar Haynes to Proposed Insured, must be properly executed, acknowledged and recorded in the Register's Office for Blount County, Tennessee.
- (e) Cancellation or release of Trust Deed from Delmar Haynes to Kenneth Clark Hood, Trustee, dated November 26, 2008 of record in Trust Book 2215, Page 1519, securing GreenBank in the original amount of \$105,000.00, must be paid and satisfied of record or the same will be set forth as an exception in the policy. (Includes other property)
- (f) County taxes for the year 2008 are due and payable in the amount of \$437.00, if paid in August, which constitutes a lien against subject property. (Lot 100)
- (g) City taxes for the year 2008 are due and payable in the amount of \$435.00, if paid in August, which constitutes a lien against subject property. (Lot 100)

 - (f) Restrictions upon the use of the premises not appearing in the chain of title to the land.
