COMMITMENT FOR TITLE INSURANCE  
Issued by



STEWART TITLE GUARANTY COMPANY, a Texas Corporation ("Company"), for a valuable consideration, commits to issue its policy or policies of title insurance, as identified in Schedule A, in favor of the Proposed Insured named in Schedule A, as owner or mortgagee of the estate or interest in the land described or referred to in Schedule A, upon payment of the premiums and charges and compliance with the Requirements; all subject to the provisions of Schedules A and B and to the Conditions of this Commitment.

All liability and obligation under this Commitment shall cease and terminate six months after the Effective Date or when the policy or policies committed for shall issue, whichever first occurs, provided that the failure to issue the policy or policies is not the fault of the Company.



## CONDITIONS

1. The term mortgage, when used herein, shall include deed of trust, trust deed, or other security instrument.
2. If the proposed Insured has or acquires actual knowledge of any defect, lien, encumbrance, adverse claim or other matter affecting the estate or interest or mortgage thereon covered by this Commitment other than those shown in Schedule B hereof, and shall fail to disclose such knowledge to the Company in writing, the Company shall be relieved from liability for any loss or damage resulting from any act of reliance hereon to the extent the Company is prejudiced by failure to so disclose such knowledge. If the proposed Insured shall disclose such knowledge to the Company, or if the Company otherwise acquires actual knowledge of any such defect, lien, encumbrance, adverse claim or other matter, the Company at its option may amend Schedule B of this Commitment accordingly, but such amendment shall not relieve the Company from liability previously incurred pursuant to paragraph 3 of these Conditions and Stipulations.
3. Liability of the Company under this Commitment shall be only to the named proposed Insured and such parties included under the definition of Insured in the form of policy or policies committed for and only for actual loss incurred in reliance hereon in undertaking in good faith (a) to comply with the requirements hereof, or (b) to eliminate exceptions shown in Schedule B, or (c) to acquire or create the estate or interest or mortgage thereon covered by this Commitment. In no event shall such liability exceed the amount stated in Schedule A for the policy or policies committed for and such liability is subject to the insuring provisions and Conditions and Stipulations and the Exclusions from Coverage of the form of policy or policies committed for in favor of the proposed Insured which are hereby incorporated by reference and are made a part of this Commitment except as expressly modified herein.
4. This Commitment is a contract to issue one or more title insurance policies and is not an abstract of title or a report of the condition of title. Any action or actions or rights of action that the proposed Insured may have or may bring against the Company arising out of the status of the title to the estate or interest or the status of the mortgage thereon covered by this Commitment must be based on and are subject to the provisions of this Commitment.
5. *The policy to be issued contains an arbitration clause. All arbitrable matters when the Amount of Insurance is \$2,000,000 or less shall be arbitrated at the option of either the Company or the Insured as the exclusive remedy of the parties. #### I. Requirements:

Instruments in insurable form which must be executed, delivered, and duly filed for record:

- (a) Owner's Lien Affidavit must be properly executed and furnished Fairway Title Company.
- (b) Notice and Waiver (declining Owner's Title Insurance) must be properly executed, and furnished Fairway Title Company if the purchaser(s) do not desire an Owner's Title Insurance Policy.
- (c) You must tell us in writing the name of anyone not referred to in this commitment who will get an interest in the land or who will make a loan on the land. We may make additional requirements or exceptions relating to the interest of the loan.
- (d) Trustee's Deed from P. Edward Pratt, Substitute Trustee to Proposed Insured, must be properly executed, acknowledged and recorded in the Register's Office for Knox County, Tennessee.
- (e) County taxes for the year 2008 are due and payable in the amount of \$334.63, if paid in August, which constitutes a lien against subject property.
- (f) City taxes for the year 2008 are due and payable in the amount of \$320.34, if paid in August, which constitutes a lien against subject property.

#### II. Schedule B of the policy or policies to be issued will contain exceptions to the following matters unless the same are disposed of to the satisfaction of the Company:

1. Defects, liens, encumbrances, adverse claims or other matters, if any, created, first appearing in the public records or attaching subsequent to the Effective Date but prior to the date the proposed Insured acquires for value of record the estate or interest or mortgage thereon covered by this Commitment.
2. Standard Exceptions:
  - (a) Rights or claims of parties in possession not shown by the public records.
  - (b) Easements, or claims of easements, not shown by the public records.
  - (c) Encroachments, overlaps, boundary line disputes, or other matters which would be disclosed by an accurate survey or inspection of the premises.
  - (d) Any lien, or right to a lien, for services, labor, or material hereto or hereafter furnished, imposed by law and not shown by the public records.
  - (e) Rights of dower, homestead or other marital rights of the spouse, if any, of any individual insured.
  - (f) Restrictions upon the use of the premises not appearing in the chain of title to the land.
3. Special Exceptions:
  - (a) Subject to a Permissive Use Agreement filed of record in Instrument No. 200012290043272, in the Register's Office for Knox County, Tennessee.
  - (b) Subject to a 10 foot easement; 5 feet on either side of the centerline of the existing facilities reserved for any and all utilities presently located within or within 5 feet of Tract 12 in the Deed of record in Instrument No. 200602270071798, in the Register's Office for Knox County, Tennessee.
  - (c) Subject to easements 50 feet in width, 25 feet on either side of the centerline of the overhead electric transmission lines, reserved for KUB Bureau of Power; an easement 20 feet in width, 190 feet on either side of the existing facility, reserved for KUB Bureau of Water; easement of 10 feet in width, 5 feet on either side of the centerline of the existing facilities, reserved for any and all other utilities presently located, within or within 5 feet of Tract 13, in the Deed of record in Instrument No. 200602270071798, in the Register's Office for Knox County, Tennessee.
