**REQUIREMENTS FOR REALTOR PARTICIPATION**

A commission will be paid to the Broker of a Licensed Real Estate Agent properly licensed in the State of **Tennessee** whose client pays and closes on the property.

To qualify for a commission, the Realtor must provide the following:

1. Register his Client by email or fax with Furrow Auction Company at least 48 hours prior to the Auction; and have that Agent & Client Relationship recognized by fax from Furrow Auction Company within 24 hours prior to the sale.
2. Agent must attend and register with the Client at the auction and bid for or with the Client.
3. Agent's commission of 2%, before the inclusion of the **Buyer's Premium** paid at closing of property. Commission will be paid only upon final closing and when the property has been settled in full.
4. Broker's identification number and the Broker's federal tax identification number.

No Realtor will be recognized as a representative of a buyer if said buyer has been personally contacted by Furrow Auction Company or Seller prior to Realtor's request for recognition. No Realtor will be recognized as a representative of a buyer if said buyer purchases and closes as a result of On-Line bidding. In the event 2 or more Realtor's request recognition for the same Client, then the one received first will be recognized by Furrow Auction Company.

The Realtor **MUST** obtain authorization by his Client acknowledging the Realtor's representation.

**No commission will be paid to any Realtor who is a Partner, Stockholder, Principal or Heir of entity purchasing the property. No commission will be paid to any Realtor representing any Partner, Stockholder, Principal or Heir purchasing the property.**

**There can be no exceptions to this procedure and no oral registrations will be accepted.**
