

GENERAL TERMS & CONDITIONS OF SALE ONLINE ONLY ABSOLUTE AUCTION: EQUIPMENT & PERSONAL PROPERTY BIDDING STARTS TO CLOSE: MAY 29 @ 10AM

Buyer's Premium:

A 15% buyer's premium will be added to the high bid. Example: For each \$1,000 bid, a 15% buyer's premium of \$150 will be added to arrive at the total purchase price of \$1,150.

Payment Terms:

Payment must be made in US Dollars and **must be made by Thursday, May 30 by 12pm (ET)**. Once an item has been sold, it becomes the sole responsibility of the Purchaser. Claims:

Registration:
