

GENERAL TERMS & CONDITIONS OF SALE ONLINE ONLY ABSOLUTE AUCTION: RENEW SOLAR INVENTORY & EQUIPMENT

Buyer's Premium:

A 25% buyer's premium will be added to the high bid. Example: For each \$1,000 bid, a 25% buyer's premium of \$250 will be added to arrive at the total purchase price of \$1,250.

Payment Terms:

Payment must be made in US Dollars and **must be made by Monday, July 14 by 2pm (ET)**. Once an item has been sold, it becomes the sole responsibility of the Purchaser. No items can be removed until a complete settlement has been made. The PAID receipt ticket will be required in order to remove items from the site. Accepted Payment Methods:

Sales Tax:

No sales tax will be collected.

Claims:

No Claims will be allowed after the removal of goods from the premises.

Registration:
