



**GENERAL TERMS & CONDITIONS OF SALE  
ONLINE ONLY ABSOLUTE AUCTION:

**Starts to Close: August 13 @ 10am**

**Buyer's Premium:**

A 10% buyer's premium will be added to the high bid. Example: For each \$1,000 bid, a 10% buyer's premium of \$100 will be added to arrive at the total purchase price of \$1,100.

**Payment Terms:**

Payment must be made in US Dollars and **must be made by Thursday, August 14, 12pm (ET)**. Once an item has been sold, it becomes the sole responsibility of the Purchaser. **Claims:**

No Claims will be allowed after the removal of goods from the premises.

**Registration:**

Bidder agrees that such Terms & Conditions are binding on the Bidder. Bidder agrees that Auctioneer is in control of the conduct of the auction sale and has the right to reject any bid by any Bidder at the auction sale.
