



## **GENERAL TERMS & CONDITIONS OF SALE**

### **ONLINE ONLY AUCTION:**

**Surplus Vehicles, Trailer, Equipment, Tools & Materials from Sign Business**

**Bidding Starts to Close: June 5 at 10am**

#### **Buyer's Premium:**

A 20% buyer's premium will be added to the high bid, except for vehicles (lots #1, #126 and #129). A 10% buyer's premium will be added to the high bid for vehicles.

#### **Payment Terms:**

Payment must be made in US Dollars and **must be made by JUNE 8 @ 1PM.**

Once an item has been sold, it becomes the sole responsibility of the Purchaser. No items can be removed until a complete settlement has been made. The PAID receipt ticket will be required in order to remove items from the site. All checks should be made payable to Furrow Auction Company. "ALL SALES ARE FINAL"

#### **Accepted Payment Methods:**

Wire Transfer, Company or Personal Check when accompanied by a Bank Letter of Guaranty, Cash or Cashier's Check. Mastercard and Visa will have a 3% surcharge.

#### **Order Of Sale:**

Items will be sold in numerical order. The highest bid at the specified closing time wins the lot. If a bid is placed within the final minutes, the system automatically extends the bidding timeframe, ensuring the auctions are always fair. The extended time may vary from auction to auction, normally between 1-2 minutes to place a higher bid. (Extended time is displayed.)

#### **Sales Tax:**

No sales tax will be collected.

#### **Claims:**

No Claims will be allowed after the removal of goods from the premises.

#### **Registration:**

By registering as a Bidder and/or participating as a Bidder in the auction sale, Bidder is bound by the Terms & Conditions set forth. Bidder agrees that such Terms & Conditions are binding on the Bidder. Bidder agrees that Auctioneer is in control of the conduct of the auction sale and has the right to reject any bid by any Bidder. It is at the sole discretion of the Auctioneer as to whether or not any bid is in conformity with the Terms & Conditions of the auction sale. Furthermore, Auctioneer may refuse to accept a bid whenever in his sole discretion bid is not in good faith. ALL PERSONS must be registered to bid.

**Inspection:**
